Introduction		Our changing ocean demands governance architectures with the connectivity to produce coordinated responses to the challenges of the Anthropocene. We have much to learn from Oceania's integrated regional oceans governance framework. In Australia efforts toward integrated oceans governance have waned since Australia's National Ocean Policy. Environmental education has an important role to play in improving public understanding of large scale connections among ocean ecosystems to reinvigorate calls for an urgent return to integrated oceans governance in Australia.				
Presentation Abstract: max. 300 words		Australia is a member of Oceania's regional institutions that comprise a governance architecture ranked the most integrated among global ocean regions. The architecture developed over 50 years through a unique Pacific Way of deliberative consensus building in regional institutional forums which transformed previously colonial-lead institutions. The 22 Pacific Island States and Territories are united in their approach to governing a				

	region they recently declared an Ocean Continent. Hope lies in the unprecedented scale of their integrated regional ocean policies. Hope that in improving understanding of the accomplishments within our region by Pacific Island States and Territories we in Australia can understand the connections we share through Pacific marine ecosystems the institutions that govern them and our role in improving Australia's marine conservation for this Ocean Continent.
Key Message: A short summary of presentation	Oceania has a highly integrated regional system of governance over an Ocean Continent Australia can learn and return to the integrated approach to oceans governance previously envisioned under Australia's Ocean Policy Environmental education plays an important role in situating marine ecosystems within the regional scale to aid the public's understanding of oceanographic and ecological connections that will help to promote integrated oceans governance
